Local State of Emergency Proclamation

A State of Emergency is hereby declared in the Town of Sanford effective at 4:00 P.M. on Friday, March 20, 2020.

The State of Emergency has been declared due to emergency conditions produced by the COVID-19 virus outbreak, and the continued threat of a rapid increase of cases thereof. COVID-19 imperils the health and safety of the citizens of this municipality, and decisive action is required in order to slow and contain its spread.

The State of Emergency shall be limited to the geographical area within the Town of Sanford.

This State of Emergency shall remain in effect until rescinded by a subsequent order.

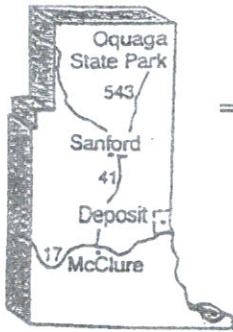

Emergency Order Closing Town Facilities

I, Dewey A. Decker, Supervisor of the Town of Sanford in accordance with a proclamation of State of Emergency executed on the 20th day of March, 2020 and pursuant to Section 24 of the New York State Executive Law, do hereby declare and order that all Town facilities including, but not limited to Town Hall, are now closed to the public for all non-emergency matters.


During this time, all meetings of the municipal boards of the Town, if and when they occur, will be accessible to the public via teleconference or live webcast. Any and all Town business shall be conducted via telephone, e-mail, regular mail or, under extenuating circumstances, by specific appointment.

This Order shall take effect on at 4:01 PM on March 20, 2020 and shall remain in effect until removed by order of the Chief Executive. This Order may also be renewed in five (5) day increments.

Any person who knowingly fails to obey this Emergency Order shall be guilty of a criminal offense, punishable by law under Section 24 (5) of the New York State Executive Law.
