Supervisor Kenny Wist called the Meeting to order at 7:00pm with the Pledge of Allegiance led by Jay Vandermark at the Town Hall, 91 Second Street, Deposit, New York 13754.

Supervisor Wist spoke on the Oquaga Lake Sewer report. The Report was reviewed. On a motion made by Dan Andresen, seconded by Jay Vandermark and all accepted the Oquaga Lake Sewer report.

Supervisor Wist gave the floor to Pete Hathaway, Code Enforcement Officer. He presented the Board with the Report of 6/13/23-7/11/23. On a motion made by Shane Lester, seconded by Dan Andresen and all approved the Code Enforcement Officers report.

Supervisor Wist gave the floor to Leo Shew, Highway Superintendent. Shew spoke on black top; a majority of roads are complete. Currently they are on Kenyon Hill Road.

Shew spoke on prep work for oil and stone on Melondy Hill Road is complete.

Shew spoke on the new 10-wheeler dump truck being delivered on June 28<sup>th</sup>; the plow will be delivered a later time.

Shew spoke on bids for a new truck through the NYS OGS.

The Town Board will discuss this at the August meeting.

Supervisor Wist gave the floor to the guests. Anne questioned the road around Sky Lake and invasive species. Alice asked Paul Langbehn when the windmills would be turned on. Paul replied with by the end of the month. Loss of power when the windmills are turned on was discussed. Paul explained that the power continues in a loop and can go either way around, the outage would shut power off on one end or the other. The short area where they're at would be dead. Three jumpers would be taken out and would be complete in one day. Potential land was discussed for the new highway garage. Wist explained the land is in the flood plain and would be costly.

**Supervisor Wist spoke on Committee Reports. The recycle bin dumpsters will need the doors repaired. The Village and Town of Deposit both approve the \$3,800 repairs plus damage repair to the front.**

**Supervisor Wist spoke on the road closure in North Sanford from July 17 through July 21.**
