Supervisor Wist called the Regular Meeting to order at 7:00pm with the Pledge of Allegiance led by Jay Vandermark at the Town Hall, 91 Second Street, Deposit, NY 13754.

Supervisor Wist gave the floor to Scott Conklin to review the Oquaga Lake Sewer Report. On a motion made by Alice Ray, seconded by Shane Lester and all approved the Oquaga Lake Sewer report.

Supervisor Wist gave the floor to Code Enforcement Officer, Pete Hathaway. On a motion made by Alice Ray, seconded by Jay Vandermark and all approved the Code Enforcement Officer's Report.

Supervisor Wist gave the floor to Highway Superintendent Leo Shew. Winter is here and plowing has begun; first few storms resulted in multiple breakdowns. The Farnham Road project is now complete. Gorick Construction has moved equipment onto Clark Road to install temporary pipes. This will allow the road to be open within the next few weeks. Due to the snow and rain; water levels are too high for the project. The water levels will be monitored. Final stages of DEC permitting for the Perry Road repairs are in process; temporary repairs should begin soon as well. Perry and Clark Roads will be one lane until repairs are complete this coming spring/summer. Hawkins Road is also currently one lane due to head wall issues and will remain one lane until the pipe is replaced; Shew does not currently have a date set for the repair to begin. Highway crew has done a great job keeping the town roads maintained. Shew wanted to remind residents to keep vehicles off town roads during this time of year as well as the turn around areas to allow the highway crew to properly maintain and plow town roads.

Supervisor Wist spoke on purchasing an extended warranty for the new International Truck; 2026 Hx620SBA 6x4 Chassis. On a motion made by Shane Lester, seconded by Jay Vandermark and all approved to purchase an extended warranty for the new International Truck at the price of \$5,445.00 for 84 months or 100,000 miles.
