NOTICE IS HEREBY GIVEN, that a Public Hearing will be held before the Town Board on March 11, 2025, at 7:00pm at the Sanford Town Hall, 91 Second Street Deposit New York in said Town regarding the adoption of a Local Law to Regulate the Operation of Lakefront De-Icing Systems in the Special and Lake Protection Overlay Zoning Districts. The Local Law would regulate the installation and use of de-icing systems on lakefront properties within Special and Lake Protection Overlay Districts of the Town of Sanford for the purpose of safe guarding public and environmental health, welfare and safety during periods of the year in which ice accumulates on waterbodies located within the Town.
